ORDER OF COURT SUPERVISION

This cause coming on for sentencing, the defendant having entered a plea of guilty or having been found guilty of:

and the court being of the opinion that the defendant is not likely to commit further crimes, the defendant and the public would be best served if the defendant were not to receive a criminal conviction, and that it is in the best interest of justice that an Order of Supervision is more appropriate than a sentence otherwise permitted under the Unified Code of Corrections,

IT IS THEREFORE ORDERED that the defendant be admitted to court supervision for a period of \_\_\_\_\_ months, upon the conditions that during said supervision the defendant shall:

1. Not violate any criminal statute or ordinance of any jurisdiction;
