- (C-5) DWLR when revocation was for Reckless Homicide
- (d) DUI (11-501) if Defendant has previously been convicted or received Court Supervision for DUI or plead guilty by plea agreement to Reckless Driving.
- (f) Overweight truck violations (15-111, 15-112, 15-301)

Person under 21 years of age with less than 1 year driving experience driving children in violation of classification (6-104(b))

Speeding in a School Zone (11-605.1)

Passing a loading/unloading School Bus (11-1414)

Speeding in a Construction Zone 26 mph or more over speed limit (11-605(d-5))

Failure to Yield to Pedestrians in Crosswalk in School Zone (11-1002.5)

(g) Court Supervision not allowed for following offenses if person has had Court Supervision or Conviction for any of those offenses or driving without insurance within the last 5 years

Driving while Registration Suspended for No Insurance if conviction or Court Supervision in the last 5 years. (3-708)

Display of False Insurance Card (3-710)

Scrap Processor Failure to Keep Records (5-401.3), if certain previous offenses for this or other offenses in (9)

- (h) Defendant under age of 21 charged with violating serious traffic offenses as defined by 1-187.001 unless Traffic Safety School is imposed or (2) If, defendant has had Court Supervision for a prior serious traffic offense, Court Supervision is not available
- (h-1) Person under 21 years of age who violates Graduated License Statute (5/6-107), any moving violation, or Seatbelt violation unless Traffic Safety School imposed.

- (i) Driving Without Insurance (3-707) if prior Court Supervision or conviction for that offense
- (j) DWLS or DWLR if Suspension or Revocation was for DUI (11-501), Leaving the Scene of an Accident (11-401), or a Statutory Summary Suspension and Defendant has had Court Supervision or Conviction for DWLS/DWLR in last 10 years.
- (k) No Court Supervision if Defendant has had 2 Court Supervision dispositions within 1 year prior to arrest except Court Supervision for DUI.
- (n) Persons under 18 years of age must appear in Court with parent in order to get Court Supervision for moving violation and violation of Graduated License Statute and Seatbelt violations.
- (o) For DWLS while under a Statutory Summary Suspension if 1st offender and did not get a permit or 1st offender and drove vehicle not equipped with BAIID device.
- (p) Speeding in Construction Zone if prior Court Supervision or conviction for that offense.
- (q) Speeding (11-601) or Speeding in Construction Zone (11-601.5) if more than 26 mph over speed limit in an urban district (as defined by 625 ILCS 5/1-214)
- (r) Any traffic offense which is the proximate cause of the death of another if Defendant has had Court Supervision for any offense other than equipment violation before.
