MCLEAN COUNTY | TRAFFIC SAFETY SCHOOL

Class Options

Four-hour Traffic Safety School classes are offered at Heartland Community College on:

- selected Wednesdays and Fridays 6:00-10:00 PM
- selected Saturdays 8:00 AM-Noon or 1:00-5:00 PM

McLean County doesn't accept online Traffic Safety school courses of any kind. If you choose to attend Traffic Safety School outside McLean County it's your responsibility to locate and schedule that class. You must pay additional registration fees at the defensive driving school where the course is offered.

Confirm Your Eligibility

You may choose the four-hour Traffic Safety School class if you:

1. went to court where the judge granted you supervision and directed you to attend
2. were not required to go to court but want to attend to preserve your driving record

You may **not** choose the four-hour Traffic Safety School class if you:

1. have a Commercial Drivers' License (CDL)
2. are under 18*
3. have already enrolled in or completed the four-hour class for a citation received in McLean County within the last 12 months**
4. have enrolled in or taken the four-hour and the eight-hour courses for two citations received in McLean County within the past 12 months

Please note, you'll forfeit all fees and a conviction will be entered in your driving record if you request Traffic Safety School and are later found to be ineligible.

**If you're under 18 you may not take Traffic Safety School unless you request a court hearing from the clerk's office and a Judge grants you that opportunity.*

***You may be eligible for the eight-hour course, but must request a court hearing from the McLean County Clerk's office.*

WHAT HAPPENS NEXT

If you went to court and the Judge granted you supervision and directed you to attend Traffic Safety School you must stop at the McLean County Clerk's office before leaving to:

- pay your fine, court costs and the Traffic Safety School fee*
- receive your driver's license/ bond card

If you were not required to go to court but want to attend Traffic Safety School to preserve your driving record:

- confirm your eligibility
- pay your fine and class fee and submit your registration form to the McLean County Clerk's office

*You will not be allowed to take your Traffic Safety School until you have paid your fees.

Your Traffic Safety School Session

Your class assignment is based on the preferences you listed on the registration form. Confirmation will be mailed to the address you provided in two-to-three weeks. If you don't receive a confirmation letter from Traffic Safety School within that time frame you must call 309-268-8159.*

It is your responsibility to complete Traffic Safety School 30 days before your supervision termination date.

If you can't attend the class assigned on your letter or wish to attend outside of McLean County, you must contact Traffic Safety School at 309-268-8159 and reschedule. The office is open Monday-Friday 8:00 AM-4:00 PM.

You will be charged a non-refundable fee of \$25.00 to schedule a new class if you:

- fail to reschedule your assigned course on or before the deadline date noted on your assignment letter
- miss your assigned class date/time

*Traffic Safety School is not responsible for late, lost or undeliverable mail. If you change your mailing address, it is your responsibility to notify the school.

If Taking Your Course Outside McLean County

You must file your Traffic Safety School certificate of completion 30 days before your supervision termination date. If you don't:

- supervision will be revoked and your license may be suspended
- a judgment of conviction will be automatically entered on your official driving record
- your automobile insurance rates may increase

Upon Course Completion

When you complete your course it is reported to the court by Traffic Safety School and **no conviction is entered on your official driving record**. You will not need to return to court unless ordered to do so by the judge.

Weather & Emergency Class Closures

Heartland Community College is committed to students' safety. Classes may be canceled due to a weather or campus emergency. If that happens, Traffic Safety School will not meet. You can check for campus closures on www.heartland.edu or on area radio and TV stations. It is your responsibility to contact Traffic Safety School to reschedule if your session is cancelled.

To reach Heartland from the Bloomington-Normal airport (BMI):

- Left on Empire (Route 9)
- Right on BUSN 51/Main Street
- Left on Raab Road
- Right to campus

To reach Heartland from the Northeast (Pontiac/Chicago area):

- I-55 South to BUSN 51 South (Exit 165)
- Left on BUSN 51 to Raab Road
- Right on Raab Road
- Right to campus

To reach Heartland from the North (Rockford area):

- I-39 South to BUSN 51 South (Exit 2) to Raab Road;
- Right on Raab Road
- Right to campus

To reach Heartland from the Northwest (Quad-Cities/Peoria area):

- I-74 East to I-55 North
- Take US-51 South to Exit 165A (South on Main Street)
- Right on Raab Road
- Right to campus

To reach Heartland from the Southwest (Lincoln/Springfield area):

- I-55 North to I-55/I-74 around the west of Bloomington and Normal to BUSN 51 South (Exit 165A) to Raab Road
- Right on Raab Road
- Right to campus

To reach Heartland from the Southeast (Champaign area):

- I-74 West to I-55 North
- Take US-51 South to Exit 165A (South on Main Street)
- Right on Raab Road
- Right to campus
