

**ADMINISTRATIVE ORDER 2018 - 02**

**ELEVENTH JUDICIAL CIRCUIT**

**2018 JUDICIAL ASSIGNMENTS IN  
FORD, LIVINGSTON, LOGAN AND WOODFORD COUNTIES**

This order supersedes all previous assignment orders for Ford, Livingston, Logan and Woodford Counties. The following assignments shall be in effect in the Circuit Court of the Eleventh Judicial Circuit, commencing **January 1, 2018**, and said assignments shall continue in full force and effect until modified by a subsequent assignment order:

All cases filed in any county in the Eleventh Judicial Circuit subject to the provisions of 750 ILCS 70 et al. (*Judicial Waiver of Notice of Abortion*) shall be consolidated before the McLean County Circuit Court as provided by local administrative order 2013-29.

All Veteran's Court cases filed in any county in the Eleventh Judicial Circuit on or after January 1, 2018 are assigned to Judge Charles M. Feeney, III (Woodford County) unless assigned by interchange to a judge within the county of filing.

**FORD COUNTY**

**Judge Mark A. Fellheimer, Circuit Judge**

Judge Matthew J. Fitton is hereby assigned all cases currently assigned to him, and all cases filed on or after January 1, 2018.

Judge Mark A. Fellheimer is hereby assigned all cases presently assigned to him and any case which may be specifically assigned by the Chief Judge or assigned by interchange agreement between Judge Fitton and Judge Fellheimer.

Judge Matthew J. Fitton is designated as the Supervising Judge for Arbitration in Ford County.

**Marriage Division**

The Resident Circuit Judge of Ford County shall constitute the marriage and civil union division of Ford County.

Judge Jennifer Bauknecht is hereby assigned all pending cases and all cases filed after January 1, 2018 in the following case categories: CF, J, JD, MR, MH, and all even-numbered D cases and any other cases assigned to her by interchange agreement with the other judges assigned to Livingston County.

Judge Bauknecht is assigned all Intensive Drug Probation Program cases.

Judge Mark Fellheimer is hereby assigned all pending cases and all cases filed after January 1, 2018 in the following case categories: CM, DT and Major TR cases, Minor Traffic, CL, CV, ED and any other cases assigned to him by interchange agreement with the other judges assigned to Livingston County.

Judge Robert M. Travers is hereby assigned all pending cases and all cases filed after January 1, 2018 in the following case categories: TX, OV, SC, LM, CH, P, L, OP, F, JA, AD and all odd-numbered D cases and any other cases assigned to him by interchange agreement with the other judges assigned to Livingston County.

Judge Matthew J. Fitton is hereby assigned all pending cases currently assigned to him, all cases filed after January 1, 2018 where the other judges assigned to Livingston County have all recused themselves and is further assigned any other cases assigned to him by interchange agreement with the other judges assigned to Livingston County.

The Resident Circuit Judge, Circuit Judge and Associate Judges assigned to Livingston County shall constitute the marriage division of Livingston County.

#### **Marriage Division**

It is further ORDERED that the Marriage and Civil Union Division of the Circuit Court of Livingston County previously constituted shall consist of the Resident Circuit Judge and other judges assigned a majority of their time to the Circuit Court of Livingston County.

Justice Thomas M. Harris, Jr. has been assigned to the 4<sup>th</sup> District Appellate Court and, until reassigned, is unavailable for assignment within the Eleventh Judicial Circuit.

Judge William Workman is hereby assigned all cases presently assigned to him and all cases filed after January 1, 2018 in the following case categories: CF, CM, CV, DT, TR, J, JA, JD, CL and all MR cases related to the Sexually Violent Persons Commitment Act, or extradition or expungement; and is further assigned to the even-numbered OP cases, and is further assigned any other cases assigned to him by interchange agreement with the other judges assigned to Logan County.

Judge Thomas W. Funk is hereby assigned all cases presently assigned to him and all cases filed after January 1, 2018 in the following case categories: AD, CH, D, ED, F, L, LM, MH, OV, P, T, SC and all MR cases not assigned to Judge William Workman. He is further assigned to the odd numbered OP cases, and is further assigned any other cases assigned to him by interchange agreement with the other judges assigned to Logan County.

Judge Funk is hereby assigned all Drug Court cases currently assigned to him and any and all such cases filed on or after January 1, 2018.

Judge Michael L. Stroh is hereby assigned all cases currently assigned to him in Logan County and all such cases assigned to him by the Chief Judge or the presiding judge of Logan County.

Judge Workman is assigned to the Marriage and Civil Union Division of Logan County.

**Presiding Judge: Charles M. Feeney, III, Resident Circuit Judge**


**Judge Michael L. Stroh, Associate Judge**

Judge Charles M. Feeney, III is hereby assigned all cases presently assigned to him, and all cases filed on or after January 1, 2018 in the following case categories: AD, CF (except CF traffic and those cases consolidated with such cases), CM, ED, JA, J, JD, L, MH, MR, P and TX. Further, he is assigned all even numbered D and F cases, D and F cases upon which he has made a ruling and any OP case as appropriate under Supreme Court Rule 903 and determined by local practice.

Judge Michael L. Stroh is hereby assigned all cases filed presently assigned to him and all cases filed on or after January 1, 2018 in the following case categories: CF Traffic and the cases consolidated with such cases, CH, CL, CV, DT, LM, OV, SC, OP, TR, TX and he is assigned all odd numbered D and F cases upon which Judge Feeney has not ruled and D and F cases upon which he has made a ruling. Judge Stroh is further assigned any other cases assigned to him by interchange agreement with the other judges assigned to Woodford County.

**IT IS FURTHER ORDERED** that the judges of each county assigned in this Order are each assigned any Contempt of Court case arising out of a case assigned to that particular judge.
