ADMINISTRATIVE ORDER 2019 - 12**

**APPOINTMENT OF CHILD REPRESENTATIVES AND
GUARDIANS AD LITEM**

Pursuant to Supreme Court Rule 906 and Rule 155 of the Eleventh Judicial Circuit, attorneys seeking to be appointed guardians ad litem, child representatives or attorneys for minor children in child custody and guardianship cases must complete appropriate education and training as set forth in Rule 155 and be approved by the Chief Judge.

NOW THEREFORE IT IS HEREBY ORDERED that the attorneys on the attached list are certified to serve as a Guardian ad Litem, a Child Representative or an attorney for a minor before the courts of the Eleventh Judicial Circuit in child custody and guardianship matters.

IT IS FURTHER ORDERED that all previous orders on this subject are hereby vacated.

Any attorney who is certified by a Chief Judge in another Circuit of Illinois in accordance with Supreme Court Rule 906 is authorized to be appointed as Guardian ad Litem, Child Representative or attorney for a minor in the Eleventh Judicial Circuit. Attorneys who are certified have an obligation to attend continuing education courses as set forth in Rule 155.
